# Presidential candidates discuss merits of increasing the Social Security tax

With less than two months until the 2008 presidential election, both candidates have expressed their views about a possible Social Security tax increase.

The Federal Insurance Contributions Act (FICA) imposes two taxes on employers, employees, and self-employed workers — one for Old Age, Survivors and Disability Insurance (OASDI; commonly known as the Social Security tax), and the other for Hospital Insurance (HI; commonly known as the Medicare tax). The FICA tax rate for employees and employers is 7.65% each — 6.2% for OASDI and 1.45% for HI. There is a maximum amount of compensation subject to the OASDI tax (i.e., \$102,000 in 2008), but no maximum for HI. Employers and employees will each pay a maximum OASDI tax of \$6,324 in 2008.

Recently, Democratic Sen. Barack Obama (D-IL) called for higher Social Security taxes on wage earners making greater than \$250,000 annually. The tax would not apply to wages between the current cap and \$250,000. The Senator has not released any other specifics on how this tax would work but has stated that his plan would "allow us to extend the life of Social Security" without raising the retirement age or cutting benefits.

Sen. John McCain's (R-AZ) position on a Social Security tax increase is less clear. In an ABC interview on July 27th, McCain said that when it comes to fixing Social Security, "everything is on the table," including a possible payroll tax increase. However, in a campaign speech after the ABC interview, McCain promised to fix the Social Security system without raising taxes.

### **Auto Update Your SSN Database.**

Each month the SSA releases an updated list of Social Security Numbers that are newly issued as of that date. PayMaster uses this list to double check your input when you enter a new hire. If you get a message when entering a SSN, it could mean that its a newly issued number and your database is out of date. If you still get a warning of a invalid SSN after updating, you might double check your input or use the built in SSA Verification report that interfaces with the SSA's online verification system.

To update your program, just go to Utilities/Apply SQL Patches and then click on Internet/Check for SQL Updates.

It should download the patch called validSSN.sql and then apply this patch to all companies.

### **State News**

#### Oklahoma Withholding.

A tax amnesty program is in effect from September 15th to Nov. 14, 2008. A taxpayer will be entitled to a waiver of penalty, interest, and other collection fees due on eligible taxes (including withholding taxes), if the taxpayer voluntarily files delinquent tax returns and pays the taxes due during the compliance initiative. The Oklahoma Tax Commission has now adopted emergency rules on the program (see http://www.tax.ok.gov/rules/ER-VCI-08.pdf)

Ohio Withholding. Delaware City voters have tentatively approved a municipal income tax increase of 0.15%. Effective Jan. 1, 2009, the tax rate will be 1.55% (the current tax rate is 1.40%)

**Indiana** There will be a new county income tax rate table in effect from Oct. 1, 2008 through Sept. 30, 2009.

**New Hampshire** Effective September 1st, the minimum wage rate increased from \$6.55 per hour to \$7.25 per hour

#### New York Wage and Hour.

A Department of Labor (DOL) investigation of the state's car wash industry found that over 78% were in violation of minimum wage and overtime laws, totaling more than \$6.5 million in estimated underpayments. The investigation was the first of several statewide proactive industry investigations planned by the Division of Labor Standards, which now conducts proactive investigations of low-wage employers regardless of whether formal complaints have been received

#### Kentucky Withholding.

Effective Jan. 1, 2008, changes to the Lexington-Fayette Urban County Government (LFUCG) occupational license tax include: (1) an initial registration fee for new businesses of \$25, (2) the requirement that businesses file copies of their Form 1099 with LFUCG, (3) revision of the due date for the annual payroll reconciliation from January 31 to February 28, and (4) revision of the penalties for failure to file or pay to 5% per month, with a minimum penalty of \$25 and a maximum of 25% (penalty was previously 4.5% with no minimum or maximum).



#### Pennsylvania Withholding.

Governor Rendell says that recent legislation (L. 2007, S1063) will provide a more efficient system for collecting local taxes. The legislation includes a number of improvements, including: (1) establishing uniform withholding remittance and distribution requirements, (2) requiring employers to withhold all local income taxes imposed on their employees' compensation and remit them to a single collector (even if the employer operates in multiple counties), and (3) instituting a continually updated tax register with a maximum of twice yearly tax rate changes. The Commonwealth will be required to issue one set of rules and regulations that apply to all taxpayers, employers, and tax collectors. The Department of Community and Economic Development will be required to develop uniform forms, notices, reports, schedules and codes for school districts, municipalities, and tax collection districts [Pennsylvania Tax Update 136, 06/01/2008].
